Subject: Notification of transactions in Unimot S.A. shares.

Zbigniew Juroszek Family Foundation with its seat in Katowice, ul. Porcelanowa 10, registered with the District Court in Piotrków Trybunalski, 1st Civil Division, under reg. no. FR 36/2023, holding tax identification number (NIP): 954-285-59-32, regon: 525364566, pursuant to art. 69 par. 1 pt. 1) and art. 69a par. 1 pt. 3) of the Act of 29.07.2005 on Public Offering, Conditions Governing the Introduction of Financial Instruments to Organised Trading, and Public Companies (Journal of Laws 2022.2554 t.j. of 09.12.2022, as amended, the "Act") notifies of the acquisition on 08.01.2024 149,900 shares in Unimot Spółka Akcyjna (the "Company") with ISIN number: PLUNMOT00013 (LEI: 259400QHBI9NV5JQT83) which caused the Zbigniew Juroszek Family Foundation, together with the parent company and related parties, to exceed 5% of the total number of votes in Unimot S.A.

In this connection, we notify:

1 / Prior to the aforementioned transaction, the Zbigniew Juroszek Family Foundation held directly 243,445 shares in Unimot Spółka Akcyjna, representing a 2.97% interest in the share capital of that company and a 2.85% interest in the total number of votes in the company
